DEFENDANT'S PROPOSED ORDER

Assuming this Court finds that the 1983 decision of Price Waterhouse to defer plaintiff's partnership candidacy violated Title VII, Price Waterhouse submits that the Court should enter the following order:

1. Price Waterhouse shall pay plaintiff back pay for the period July 1, 1983 through June 30, 1984.

2. Plaintiff shall be awarded reasonable attorneys' fees, plus costs to be determined by the Clerk. The parties shall attempt to agree on an amount to compensate for such reasonable attorneys' fees and advise the Court in writing within 30 days of the entry of this order whether proceedings to establish the fee award will be necessary.




